#### 3. TERMS & CONDITIONS

Should the maximum occupancy be exceeded the resort shall have no alternative but to insist that the number of guests exceeding the maximum immediately leave the resort or book alternative rooms.
- 3.3. The booking will be confirmed with a confirmation letter and the confirmation letter must be produced on check-in at the resort, and failing such the resort may refuse admittance.
- 3.4. Only the guests whose name appears on the confirmation letter will be permitted occupation.
- 3.5. The resort may, for practical reasons if deemed necessary, be required to change the location of the Guests unit and reserves the right to assign a different unit without prior notice.
- 3.6. # 4. CANCELLATIONS POLICY

- 4.1. No verbal cancellation will be accepted.
- 4.2. A 30% of the total amount will be charged if cancelled within 72 hours before date of arrival.



- 4.3. No refund for cancellation made on the day of arrival
- 4.4. No show and cancelling under 72 hours.
- 4.5. No Refunds will be made to bookings during peak season or major events, unless a replacement guest is booked.
- 4.6. Refunds on deposits will be done only if a cancellation is received 21 days Prior to arrival.
- 4.7. A R150.00 administration fee will be levied on all bookings cancelled.
- 4.8. In the event of the Lodge/Hotel instructing attorneys to collect any amounts owing, all legal fees and collection charges between attorney and guest / client shall be borne by the guest / client.
- 4.9. A no-show is a non-arrival of a Guest without notification in writing (fax or e-mail) to the Lodge/Hotel. In case of a no-show, payment will be forfeited, or alternatively you will be liable for 100% no-show fee if payment were not made prior to arrival.
- 4.10. The resort serves the right to cancel any booking forthwith and without liability on its part in the event of any damages or destruction of the allocated units by fire, floods or other causes. In the event of the agreed full payment not received by the stipulated date on the confirmation letter, Patong Lodge & Hotel shall be at liberty to release the reservation without notice to you.
